**RE: HEALTH PRACTITIONERS 4 CHOICE// SARU: COVID-19 VACCINATION POLICY**

The above bears reference.

1. We represent a group of concerned citizens consisting of general practitioners, medical specialists, medical researchers, attorneys, and businesspeople (my clients) and have been instructed to address this letter to you.

2. We therefore state on record the following as fact:

2.1 SARS CoV-2 is a virus that does **not** pose a threat to healthy young men and women. The risk of serious disease or death in healthy young people is about 0,003%.

2.2 Natural immunity and not vaccine generated immunity is the strongest form of immunity that any person can have against respiratory viral infections and Covid-19.

2.4.5 The so-called vaccines have proved to be **unsafe**.   - ii) The wearing of masks in public spaces was also abolished provided that proper social distancing was adhered to.

- ii) Government Notice 1882, dated 15 March 2022 (Government Gazette 46048);
- iii) Government Notice 1880, dated 15 March 2022 (Government Gazette 46045);
- iv) Government Notice 1879, dated 15 March 2022 (Government Gazette 46045);
- v) Government Notice 1878, dated 15 March 2022 (Government Gazette 46045);
- vi) Government Notice 1877 dated 15 March 2022 (Government Gazette 46045).

7. We understand that the events of the last two years have been frightening to many and confusing to most. My clients, as experts in their various fields of practice understand that SARS CoV-2 does in fact not pose the threat to our young men and women as perceived by the public.
