- So little harm as not to matter? or
- Something else? or
- Less harm than the alternative? (in this case please see further questions on next slide)

## QUESTIONS FOR VAX-PUSHERS

### OWN KNOWLEDGE – i.e. EXPERT

- Please disclose what alternative/s you have taken into account?
- Please disclose the facts, methodology and findings of the risk/benefit analysis you conducted?

## QUESTIONS FOR VAX-PUSHERS

### OWN KNOWLEDGE – i.e. EXPERT

When you assert that the mRNA or DNA injectables are “EFFECTIVE”:

- What are the beneficial effects to which you refer?
- Do you mean that they effectively prevent transmission of the SARS-CoV-2 virus?
- Do you mean that they effectively protect people from getting positive PCR tests – or from getting the COVID-19 illness?
- Do you mean that they effectively protect people from severe illness or death? (in this case please see further questions on next slide)

## QUESTIONS FOR VAX-PUSHERS

### OWN KNOWLEDGE – i.e. EXPERT

When you assert that the mRNA or DNA injectables are “EFFECTIVE” at protecting people from severe illness or death:

- Do you mean that the protection relates only to severe illness or death from COVID-19?
- Do you mean that the protection relates to all causes of severe illness or death?
- What are the findings of all-cause morbidity/mortality studies you have reviewed?
